From the 7th to the 18th of November, the 22nd Climate Summit (COP22) takes place in Marrakech, Morocco, an opportunity to defend and address the causes of climate change and to implement the decisions taken at the previous COP21 in Paris.

The Climate Conference in Morocco is a good time to draw attention to the importance of renewable energies and Euro-Mediterranean energy cooperation. Morocco is undoubtedly committed to renewable energies as seen in the programs that is promoting. The problem is that many of these projects are not implemented in Morocco but in the territory of Western Sahara.

Currently 22 windmills manufactured by the German company Siemens provide 95% of the energy needed by the Moroccan national company OCP for the controversial exploitation of phosphates in the territory of Western Sahara occupied by Morocco. Morocco has ambitious plans regarding the installation of wind farms in Western Sahara. In 2010, the Moroccan government decided to double national wind power production by increasing its capacity to 1000 MW by 2020. 40% of that additional capacity (400 MW) will be developed in Western Sahara.

The Court of Justice of the European Union recently ordered the annulment of the EU-Morocco Free Trade Agreement as long as it applied in the territory of Western Sahara.

We, the undersigned, demand:

- Member States to provide information to companies wishing to invest on the Moroccan government's activities in Western Sahara contrary to international law.
- The European Union to ensure that its Moroccan energy imports do not include energy from Western Sahara and that its institutions comply with the EU's commitment not to allocate EU funds to these programs in Western Sahara.
- The Secretary General of the United Nations to ensure compliance with United Nations resolutions regarding the exploitation of natural resources in a Non-Self-Governing Territory.
